Type of call: Collaborative projects (small or medium-scale focused research projects)

### FP7-OCEAN-2010

Call date: 30 July 2009  
Closing date: 14 January 2010  
Budget: EUR 34 million (EUR 1 million from Theme 8: SSH budget)  
Type of call: "The ocean of tomorrow" joint call

### FP7-SSH-2010-3

- **The SSH programme introduces a new approach as from the 2010 Call for Proposals.** The new approach, designed in consultation with the scientific community and Member States is based on identification of a number of important societal challenges facing Europe in short to medium term perspective. - On 15 June 2009, the Commission decided to **maintain the FP7 transitional flat rate for indirect costs at 60%** for the purposes of grants awarded to non-profit public bodies, secondary and higher education establishments, research organizations and small and medium enterprises under calls closing after 31 December 2009.
